## Who we are?

We Are with You Charitable Trust is a non-governmental organization working in the fields of education, environment, health and community service activities. We are group of students working to help, guide, and empower people to improve the quality of life among citizens. With the help of student community, we reached more than 8,000 beneficiaries through our activities.

## Our services

We Are with You Charitable Trust wanted to help and reach more people with different initiatives. We categorised our initiatives into five types.

- **Student Empowerment**

Education plays a key role for development of the society. It provides an opportunity to enhance the quality of lives. But an awareness is required among parents about the same. To make this happen, our team organised rallies to create awareness. We visited many government schools and guided students with career guidance classes. With the support from teachers, we organised digital classes for students to help them understand education related concepts clearly. We conducted different competitions among students of government hostels and gifted them with prizes. We organised surveys in different slum areas to identify problems of the people there and provide solutions for them. We took the children of these slum areas on a trip to expose them to outside world. We guided few economically backward students providing education related needs like stationery. In total, we have reached more than 4000 people with the initiative.

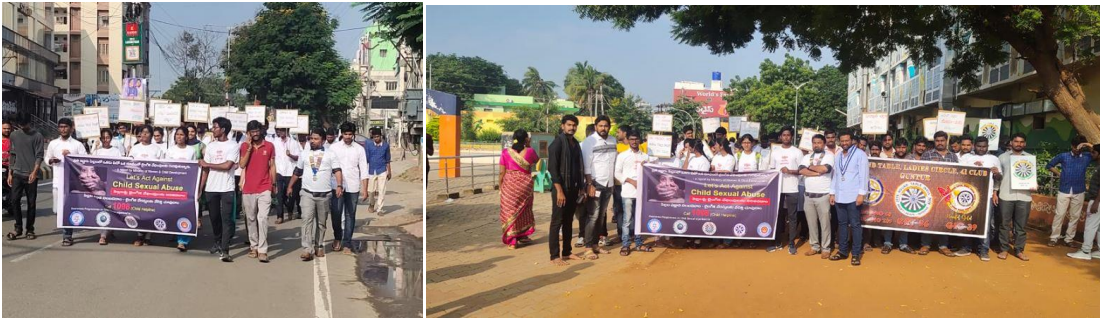






- **Women Empowerment**

Child sexual abuse is one of the major concerns of girls these days. To create awareness on child sexual abuse, with the guidance from Padala Charitable Trust, and in association with organizations like Padma Poojitha Foundation, Round Table Guntur, Sparsha Foundation, and D-Help Foundation we organised a rally from NTR Stadium to Sankar Villas centre Guntur. The rally created awareness among more than 1000 participants. Along with this rally we organised awareness sessions in slum areas at Guntur and empowered more than 250 women.



- **Health Services**

To create awareness on health, our team has organised a medical awareness session and medical camp at Vaddera Colony, Pedakakani Village. With the support from doctors at Viswas Hospitals, Guntur we have organised a medical camp with basic check-ups and distributed required medicine with support of medical consultants from Poornima Medical Agency, Guntur. A total of 300 people were examined in the medical camp and medicine was distributed by Poornima Medical Agency to required people.



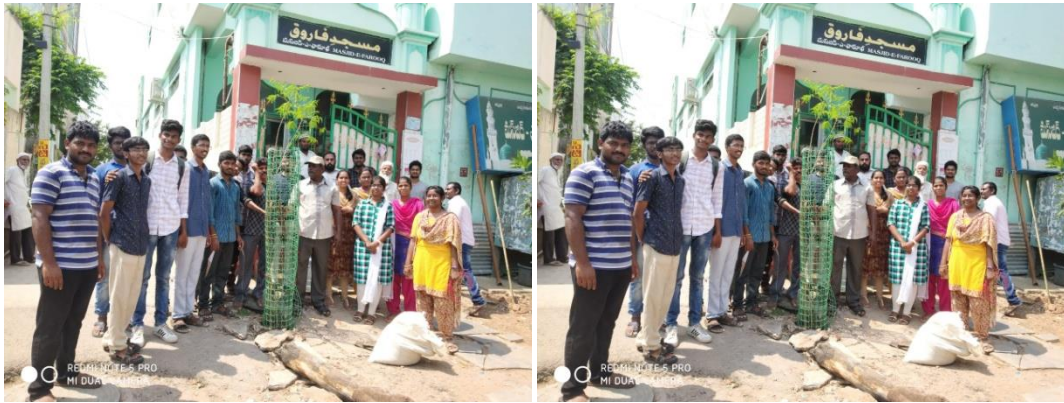
- **Community Service**

There are a lot of people who are in need of food and clothes. To help these people we organised voluntary food distribution activities with the support from Amma Charitable Trust. We collected excess clothes from donors and donated them at slum areas. Our team visited orphanages and blind houses to support kids there by providing required care. In total we have reached more than 3,100 people with the initiative.



- **Environment Responsibility**

Nature gave us a lot of benefits. It is our responsibility to give back to nature. So, we have planted more than 100 trees to protect the environment in and around city of Guntur.
