This gave me an opportunity to interact with team personally. The visit gave a great impact on team and there is an immediate result on the branches and volunteers.

While preparing this report, it reminded my team and me of the work we did to support needy families, our relationships with different organizations and NGOs, and the impact we created in just three years. It was all possible because of the support from every donor, volunteer, and partner organization. I am grateful to my team, volunteers, donors, and partner organizations to reach and help needier people.

# WHO WE ARE




We Are with You Charitable Trust is a youth driven non-governmental organization addressing multiple social problems with a volunteer network more than 1,000 in Andhra Pradesh, Telangana and Tamil Nadu. With nine different projects we are addressing multiple issues including education, health, environment and poverty. We have 4 projects dealing with education and 5 projects dealing with health, environment and poverty.

With these projects we reached more than 33,000 needy people from April 2021 to March 2022. We organized Student Empowerment Trainings, Career Guidance sessions, books distribution, blood and health camps, menstrual hygiene awareness sessions, food and clothes collection and distribution camps and many more. With the strong volunteer network, support from partner organizations and guidance from the advisory board we aim to serve more who need quick attention.

## **EVOLUTION**

We Are with You Charitable Trust has a very strong volunteer network in Guntur. During first wave of COVID19 most of us are residing at home doing nothing. We wanted to help more needy and decided to expand our wings by starting our branches across multiple cities. With the branches in the first wave of COVID19 we did less activities as most of the branches are in their induction stage. During the second wave of COVID19 our team became strong across many branches and did many COVID19 support services. When the situation started getting normal we decided to stabilise all the branches. We started training the core team consisting of President, Vice-President, Secretary, and Joint-Secretary. With the help of core team we created a team of dedicated volunteers and trained the most active volunteers as project leads. We selected and trained volunteers to create and share content on social media. With the support of the core team we developed a local advisory board to support the branch. Next to support needy in the local branch we needed to develop a strong local network to support our activities which led us to collaborate with schools, hospitals, blood banks, old-age homes and orphanages. With strong advisory board, project leads, core team and local network we stabilized in many of our branches and are ready to serve more needy.

#### IMPACT OF PROJECT BHAVISHYA















We are dedicated to supporting underprivileged students get the best education in academics and overall development in their skills. Our team visited government schools and organized Career Guidance and Student Empowerment Training sessions. We designed a book named Bhavishya – the book with data containing various career opportunities and scholarships available for students. We distributed more than 1600 books for free in government schools we visited. We organized Children Fest, a three-day event at Sri Sarada Niketan Public School at Martur. We interacted with the children and identified the needs of students in the hostel. We contributed directly and helped bring sponsors to develop the necessary infrastructure required in the school. We started a new initiative called Future - to share life stories of unknown inspiring people and lives sessions from socially responsible and motivation speakers to inspire volunteers.

#### IMPACT OF PROJECT VAARADHI
















We know the problems faced growing up as a poor, orphan, or semi-orphan student. Our Project Vaaradhi is initiated to support these students both emotionally and financially. We have a personalized volunteer caretaker for each student. The caretakers interact with the children twice a week and understand students' performance in academics and extra and co-curricular activities. The caretaker identifies if the student or family is in any need and notifies the project lead. The lead and the Chairman verify the condition and support the family whenever required. During COVID19's second wave, we supported families of Vaaradhi students by providing essential groceries and rice. We started tutoring sessions only for Vaaradhi students to help them grow strong in academics.





#### IMPACT OF PROJECT SCHOLARSHIPS





We don't believe that being poor stops us from achieving our goals. Mr. Ayyappa Siginam, Chairman and Founder of We Are with You Charitable Trust, and many of our volunteers are pursuing their higher education entirely with the help of scholarships. We gathered scholarships from various sources and included them in our book Bhavishya. These scholarships will be helpful to the students starting from class 10 to undergraduate students with different degrees. This year we got support from India's largest scholarship platform Buddy4Study. With the help from Buddy4Study we shared the scholarship opportunities from more than 40 organizations. We supported a few students who are strong in academics by paying their college fees and guided many students to apply for different scholarships.



#### IMPACT OF PROJECT GRANDHALAYA




A good book is better than thousand friends, and a good friend is equal to a library. We believe in this statement and initiated this project to support those who need books. This year we shared the details of many courses and sites that provide books for free. Last year we opened a mini-library at Sharon Children Home with almost 100 books, and the impact they created is clearly visible this year. The students started reading biographies and novels. These books positively impacted the students. We acted as a bridge between a student who needed JEE books and a donor who already had these books with them.



#### IMPACT OF PROJECT AAROGYA




Through Project Aarogya, during the second wave of COVID19, we sponsored the medical equipment, beds and medicine at Gurram Joshua Isolation Centre in Guntur. Along with the support from the friendly organization Sparsha in Guntur and support from organizations in CONNECT we started Telemedicine online medical consultancy for free during COVID19. With support from organizations in CONNECT we launched an app and operated it for two months to share verified and urgent information about blood, food, oxygen, and hospital beds during second wave of COVID19. We conducted nine blood donation camps in 5 branches and collected around 500 units of blood. We conducted eye camps and heart check-ups at slums and schools. The camps helped more than 15 people detect heart disease and received free treatment from the government. With support from Sparsha, we started a free medical clinic at Pragathi Nagar. The clinic will be operated on once a week and have basic health check-ups. We started creating awareness about organ donation, and our team registered to donate organs after death. Under the initiative Bharosa, we supported two volunteers sponsoring partial hospital bills.



#### IMPACT OF PROJECT ABHAYA




Through Project Abhaya, we visited ten orphanages and five old-age homes, interacted, and regularly spent time with kids and elderly people. We have an initiative called Celebrations by WAYCT, where we celebrate birthdays in orphanages and old-age homes, and this year we celebrated many birthdays. We conducted a medical camp for the children at Sharon Children Home. The camp included eye and dental check-ups. We sponsored sports kits, books, and required stationery to the children in orphanages through this project. With this project, we supported more than 300 students and helped sustain some orphanages. We donated an auto to Sharon Children home to help the kids who are walking 4 Kilometres to go to school from the orphanage. We conducted free eye and dental check up for the children at Sharon Children Home. With the support from sponsors we provided treatment to the children who have dental and eye issues.



#### IMPACT OF PROJECT ANNAPURNA



COVID19 destroyed livelihood of many families. Many families lost their earning member, people who are daily wage labourers to private school teachers did not have money to buy essentials as everything stopped working. With support from sponsors we directly went to homes of needy families and distributed rise and essential groceries to them. We helped in getting employment opportunities to two families by donating two sewing machines. Floods affected many places this year very severely. With the support from many organizations, we organized flood relief camps in Chennai, Kadapa, Nellore, and Tirupati branches. We conducted nine clothes collection and distribution camps through the project. We supported more than 2000 people under Project Annapurna.



#### IMPACT OF PROJECT PARYAVARAN










To increase awareness about greenery and plants, we started a Greenery Challenge initiative. We completed two seasons and started the third season of the Greenery Challenge. We got more than 200 people who planted trees in the challenge. With support from TeluguPeople Foundation, we organized an event called Maha Vrukshotsav. Mr. Lava Kusha from TeluguPeople Foundation sponsored us and because of him this event happened in the first place. In this event, we planted 500 trees in a single day. We initiated Swaccha Vidyalaya as a new initiative this year. Under this initiative, we go to schools and explain the importance of cleanliness and its impact on health and the environment.



#### IMPACT OF PROJECT SWECHHA



With Project Swechha, we conducted three online workshops on Adolescent Health Education Training. We conducted these workshops offline at orphanages and schools. We created awareness about changes in adolescent age, menstrual hygiene, child sexual abuse, and related acts, child marriages, and various social issues through the workshop. We impacted more than 500 girls through the project. We visited slums, villages, schools and colleges, organized awareness sessions and distributed menstrual pads. We trained some NGOs under this project.

# CONNECT

Initially, we don't know about the various formal and legal processes involved while managing an NGO. Luckily, we were under the guidance of Mr. Padala Surya Prasad – Founder and CEO of Padala Charitable Trust. Many individuals want to serve the needy and start NGOs for different causes, but they lack guidance. Within our experience, to support these NGOs and reach more needy, we initiated CONNECT.

CONNECT is a platform where young NGOs across the state connect to support each other and reach more needy. More than 50+ organizations, both registered and unregistered, are in CONNECT across Andhra Pradesh and Telangana. We organized online sessions to guide new NGOs to help them in the registration process, applying for a bank account, applying for a PAN card, and many more. Some organizations invited us to be part of their advisory board to support them at every step. Apart from online sessions, we collaborated and organized many offline events to help needy.

On 6 October 2021, on the occasion of our anniversary to encourage new NGOs, we appreciated some of the well-doing NGOs in and around Guntur. We awarded them with a Certificate of Excellence from the hands of our Honourable Advisor Mr. Addanki Sridhar Babu, IAS. Through CONNECT, we organized many blood donation camps, clothes collection, and donation camps. During the second wave of COVID19, we unlocked the full potential of CONNECT and reached more than 15,000 needy.

CONNECT will always be a successful platform to reach more needy and create more leaders.

# **VOLUNTEER BENEFITS**

We are always thankful to the volunteers. Without them, we could not have reached many needy. We regularly recognize and appreciate the volunteers who contribute actively. We initiated Bharosa – to support volunteers emotionally and financially to the extent we can.

Not only contribution from volunteers, but we also focus on the career of our volunteers. We organized resume-building sessions, sessions to explain the tips to crack interviews, and many more. Crazy Club is an initiative started to help volunteers speak English fluently. We created an Open Club, a place for volunteers to share whatever they want. They can sing, dance, play games, share their problems with a set of people, and many more.

We Are with You Charitable Trust is a place where a volunteer contributes to society and grows as a person. We have many volunteers who joined our team with a sense of doubt themselves, but they transformed into true leaders within time. We are proud to say that we are generating leaders.

Our volunteers studying the final year of their graduation were placed in more than one MNC. The primary reason all the volunteers express is We Are with You Charitable Trust helped them grow personally as a person and build confidence and communication skills, which helped them grow and get placed in multiple MNCs. 





